

## **ABA THERAPIST-Special Education**

**Reports to: Director of Special Education**

**Classification: Classified**

**FLSA Status: Non-Exempt**

**Terms of Employment: 12 hours per week as prescribed by IEP**

**Evaluation: Performance in this position will be evaluated by supervisor and in accordance with Board Policy**

**Compensation: Reviewed and established annually by the Board of Education**

### **JOB SUMMARY:**

Provide special instruction to an eligible child at the student's home or at a mutually agreed upon alternative setting in accordance with the student's Individualized Education Program.

### **ESSENTIAL DUTIES AND RESPONSIBILITIES: *Additional duties may be assigned.***

- Provides direct ABA therapy to an individual student.
- Collects appropriate trial data to report on student progress toward skill mastery.
- Maintains regular attendance.
- Maintains appropriate communication with parent, special education teacher and Autism/Behavior Consultant.
- Complies with State Law and District policies and regulations.
- Maintains a safe environment for the student, conducive to learning.
- Assist in other physical ways as identified by the IEP.
- Anticipates and effectively addresses unforeseen crises associated with working with large groups of students.
- Ability to implement programs based on district and school objectives and the needs and abilities of the student to whom assigned.
- Attends district workshops as directed.
- Maintains confidentiality, unquestionable integrity.

### **SUPERVISORY RESPONSIBILITIES:**

Assist the teacher in the supervision of students in the classroom and on community access/field trips.

### **QUALIFICATIONS AND REQUIREMENTS:**

*To perform this job successfully, an individual must be able to perform each essential duty satisfactorily.*

### **EDUCATION AND/OR EXPERIENCE:**

- High school diploma or equivalent.
- 60 hours of college credit may be required for some paraprofessional positions.
- Prefer prior experience working with students with special needs.
- Prefer prior experience using applied behavioral analysis or discrete trial teaching.

### **COMMUNICATION SKILLS:**

- Ability to effectively present information and respond to questions from administrators, students, staff and the general public consistent with the duties of this position.

### **MATHEMATICAL SKILLS:**

- Ability to add, subtract, multiply, and divide in all units of measure consistent with the duties of this position.
- Ability to apply concepts such as fractions, percentages, ratios, and proportions to practical situations consistent with the duties of this position.

### **KNOWLEDGE, SKILLS AND ABILITIES:**

- Ability to work with individual students to support academics and behavior management.
- Must have patience working with students with special needs.
- Ability to learn new skills, flexibility and willingness to perform a variety of tasks.
- Ability to establish and maintain effective working relationships with students, peers, parents, staff members, and departments and business contacts outside of the District.
- Is self-directed, and works without direct supervision.

**REASONING ABILITY:**

- Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists consistent with the duties of this position.
- Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form consistent with the duties of this position.

**OTHER SKILLS AND ABILITIES:**

- Ability to accurately perform assigned tasks.
- Ability to perform duties in full compliance with district requirements and School Board Policies.
- Ability to promote harmonious working relationships with staff, students, and parents.
- Possesses oral and written communication skills consistent with the duties of this position.
- Possesses interpersonal relationship skills consistent with the duties of this position.

**PHYSICAL DEMANDS:**
