JOB SUMMARY:

To supervise children in Kidz Care Extended Day Care Program and Kidz Zone Before/After School Programs.

ESSENTIAL DUTIES AND RESPONSIBILITIES: *Additional duties may be assigned.*

- Supervision of children ages 3-5 in child care setting
- Organize and implement age-appropriate activities
- Manage student behavior constructively
- Maintain a safe environment for students
- Communicate with parents and address any parent concerns
- Maintain attendance records.

SUPERVISORY RESPONSIBILITIES:

- Supervises children, other responsibilities as assigned

QUALIFICATION REQUIREMENTS:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill and/or ability required. EDUCATION AND/OR EXPERIENCE:

- High school diploma or equivalent
- Early childhood degree or at least 60 college hours preferred.
- Prior experience working with children required.

OTHER SKILLS AND ABILITIES:

- Must enjoy working with children.
- Must deal pleasantly with staff, parents, and students.
- Must be a self-starter who can take charge of situations and be able to solve practical problems.
- Maintain confidentiality; unquestionable integrity.
- Ability to perform duties in full compliance with district requirements and Board policies.

PHYSICAL DEMANDS:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly required to sit and talk or hear. The employee frequently is required to walk and use fingers, tools, or controls. Occasionally the employee will lift up to 50 lbs. such as to lift files and paper.
